 3 THE VICTIM & SUSPECT HAD A FORMERLY DATING RELATIONSHIP.  
 4 THE VICTIM WENT TO THE SUSPECT'S RESIDENCE TO CONFRONT HIM OVER  
 5 UNAUTHORIZED ACCESS TO HER EMAIL ACCOUNTS, THE CONFRONTATION  
 6 TURNED PHYSICAL. THE VICTIM HAD VISIBLE INJURIES ON HER  
 7 LEFT ARM, CHEST, & FACIAL AREA. THE VICTIM WANTED TO PRESS  
 8 CHARGES FOR BATTERY. THE SUSPECT HAD LEFT THE SCENE  
 9 PRIOR TO POLICE ARRIVAL.

10 WHILE FOLLOWING UP ON THE SUSPECT'S IDENTITY, THE

1 UNAUTHORIZED ACCESS TO HER YAHOO EMAIL ACCOUNT,  
2 FACE BOOK ACCOUNT & MYSPACE ACCOUNT. SHE SUSPECTED  
3 THE SUSPECT WAS RESPONSIBLE FOR THE UNAUTHORIZED  
4 ACTIVITY.

5 ON 09-29-08, DURING THE LATE EVENING HOURS, THE  
6 VICTIM WENT TO HER NEIGHBORS RESIDENCE, [REDACTED]  
7 [REDACTED], AT [REDACTED] WHILE THERE, SHE MET WITH THE  
8 SUSPECT. THE VICTIM & THE SUSPECT THEN WENT TO THE

2 THE VICTIM EVENTUALLY WENT BACK TO THE DOOR TO  
 3 TRY TO LEAVE. AT THE DOOR, THE SUSPECT GRABBED HER

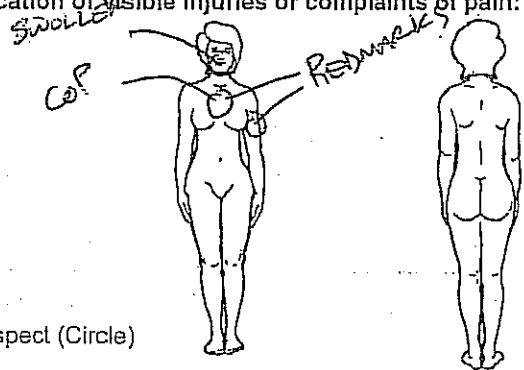

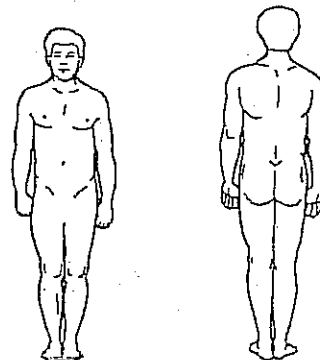

**Narrative:** On 093008 at approx 0008hrs I responded to 334 Santana Row on a family disturbance call. Upon arrival I assisted on the call by taking photos of the (V)'s injuries. The photos were booked into central supply. I then left the scene.

At approx 0128hrs I responded back out to 334 Santana Row to assist Ofc McGill #3004 in taking the (S) into custody. Upon my arrival the (S) had already been place into handcuffs. I transported the (S) to the SCCo Jail. While I was in the holding cell I read the (S) his Miranda rights as per my dept issued Miranda card. The (S) stated he understood his rights and wanted to tell his side of the story.

**Statement of Subject Dhiraj Marya (S):** The (S) stated he and the (V) had started dating in April 2008. They had been broken up for about a month and he had not talked to her for at least a couple of weeks. On today's date he had received a call from "Ebreham" who was a friend of the (V)'s. He asked if the (S) could come over to his house to explain an email he sent to the (V). The email had stated that the (V) should not trust "Ebreham." When the (S) got to "Ebreham's" house the (V) was also there. The (S) told "Ebraham" that he never sent the email and that it must have been forged. After they talked awhile "Ebraham" asked the (S) if he could be a witness to the fact that the (V) owed him \$30,000 and that she would pay him back. He witnessed the (V) telling "Ebraham" that she owed him the money and would pay him back.

When he came to "Ebraham's" house he had brought over two boxes with some of the (V)'s property that she had left at his house. When the (S) was leaving "Ebraham's" house the (V) left at the same time. The (V) asked if they could talk and started to cry in the hallway. He told her that they could talk but first they would have to drop off her belongings at her house. For unknown reasons the (S) decided to take her belongings with them to his house. They were there for about an hour talking about their relationship. She stated she loved him and wanted him back. She asked him not to go on his trip and that she wanted to get back together. He told her that he did not want to get back together. She got angry and grabbed his laptop and took off running out of his house. The (S) chased her down the hallway and grabbed his laptop out of her hands. He saw his friend "Alex" in the hallway and the (V) began to scream for him to call the police because "he stealing my laptop." The (S) opened the laptop and showed "Alex" that the laptop belonged to him. "Alex" saw that the (V) was fine and that she had not been assaulted. The (V) then left and he went to his mother's house to get some luggage for his trip. When he returned he was arrested. The (S) stated he never pushed the (V), grabbed her or pulled her hair.

I then booked the (S) into jail for domestic violence.
